



The APCD Council is a program of NAHDO in partnership with the Institute for Health Policy and Practice (IHPP) at the University of New Hampshire (UNH).



#### Recap CAA Section 115 Data Access Requirements



- To be eligible for grants, State APCDs must have (or intend to have) a data access process
- Law offers guidance on:
  - Who must be allowed to request data
  - Purposes that must be supported
  - Types of data products

### Data Products in CAA Section 115



- Data for Research Purposes
- Customized Reports
- Non-Customized Reports
- CAA does not define requirements for Data Products, only broad categories

#### **Data for Research Purposes**



#### What does the CAA say?

- Use to evaluate health system performance
- IRB approval required, if applicable
- Prohibits attempts to reidentify & disclose Individually Identifiable Health Information (IIHI) and proprietary financial information

APCD Data Products	What is Included?
Limited Data Set	<ul> <li>Some patient-specific information</li> <li>Some Payer/Provider IDs, payment information</li> <li>Can be "off the shelf" or usually custom</li> </ul>
Identifiable Data	<ul> <li>Detailed patient-specific information</li> <li>Payer/Provider IDs, payment information</li> <li>Custom request, justify sensitive information</li> </ul>

## **Customized Reports**



#### What does the CAA say?

- For employers and employer organizations, provided at cost
- Format must protect data privacy, security, proprietary financial information

APCD Data Products	What is Included?
Custom, Topic Specific or <i>ad hoc</i> Reports	<ul> <li>Typically produced by APCD analysts</li> <li>Descriptive statistics or summary results</li> <li>Presented in tables or visualizations</li> </ul>
Custom De-Identified Data Sets	<ul> <li>No patient specific information (IIHI)</li> <li>Limited payment or sensitive information</li> <li>Do these qualify as CAA "aggregate data sets"?</li> </ul>

## **Non-Customized Reports**



#### What does the CAA say?

- Available to all "authorized users" (CAA lists: research entity, employer, health insurance issuer, third-party administrator, health care provider)
- Specifies "aggregate data sets" provided at no cost

APCD Data Products	What is Included?
Public Use File	<ul> <li>No patient specific information (IIHI)</li> <li>Limited payment or other sensitive information</li> <li>Aggregated data</li> </ul>
Public Facing Reports	<ul> <li>Topics of broad interest, often available on a website</li> <li>Descriptive statistics or summary results</li> <li>Presented in tables or visualizations</li> </ul>

### Data Products: Who are the Audiences?



CAA Category	APCD Examples	Audiences
Data for Research Purposes	<ul><li>Limited Data Sets</li><li>Identifiable Data</li></ul>	<ul><li>Academic Researchers</li><li>Research Institutions</li><li>Graduate Students</li></ul>
Customized Reports	<ul> <li>Custom, Topic Specific or ad hoc Reports</li> <li>Custom De-identified Data Sets (?)</li> </ul>	<ul> <li>Employers (CAA)</li> <li>State Agencies</li> <li>Providers, Payers</li> <li>Non-profits</li> <li>Advocacy groups</li> <li>Governor/Legislature</li> </ul>
Non-Customized Reports	<ul> <li>Public Use Files or "aggregate data sets"</li> <li>Public Facing Reports</li> </ul>	<ul> <li>Similar to Customized Report Audiences</li> </ul>

## Data Access Committee Role



#### Primary Purpose

- Review data requests and make recommendations
  - May also provide input on data access policies and data products
- Broad healthcare community representation with a diversity of perspectives
- APCD's in development or those without a Data Access Committee may look to an APCD Advisory Committee for guidance on data products

### How to Get Started



Existing APCDs	<ul> <li>Do you have a Data Access Process? If not, what changes are needed to establish one?</li> <li>Does your Process allow access for: <ul> <li>Researchers, Employers, Payers, TPAs, Providers</li> <li>If not, what changes are needed?</li> </ul> </li> <li>Do your existing Data Products include: <ul> <li>Research Data Sets, Customized Reports and Non-Customized Reports</li> <li>If not, what changes are needed?</li> </ul> </li> <li>Take inventory and start planning with CAA in mind</li> </ul>
APCDs in Development (Includes Voluntaries or entities contemplating an APCD)	<ul> <li>Do you have an Advisory or Data Access Committee?</li> <li>If not, establish to engage stakeholders, obtain input</li> <li>Learn from existing APCDs, seek expert assistance</li> <li><u>A credible Data Access Process plan is required; still time</u> to make necessary changes and build one!</li> </ul>
